The Uniform Appraisal Dataset (UAD) 3.6 Is Almost Here

The new UAD 3.6 is just around the corner. The SFREP development team has been working tirelessly to provide the best program as soon as possible, so you can be prepared.

The timeline is clear. Starting September 8, 2025, UAD 3.6 reports will be accepted by lenders who are ready, have been approved, and request UAD 3.6 reports. Current UAD 2.6 reports will continue to be



accepted through November 1, 2026, at the lender's discretion. After that time, the new UAD 3.6 will become mandatory, and UAD 2.6 will no longer be accepted. By May 2027, the pipeline should be clear of all UAD 2.6 orders, and the old format will be retired. The timeline only applies to Fannie Mae and Freddie Mac. FHA, VA, and USDA all intend to eventually adopt UAD 3.6. We will keep you updated as we have information

We expect UAD 3.6 report requests may be limited initially and then ramp up through 2026. SFREP has chosen what we think is the best option for appraisers to continue their work with as little disruption as possible. You may continue to work with the Appraise-It Pro that you are used to. Simply find the new UAD 3.6 report in your list of new forms and start your report. Watch your new dynamic reports change as you write them and feel confident that what you see is what your clients will receive.
